# **Citywide Parent Council (CPC) Meeting Minutes**

18 August 2015, 6-8pm

Meeting Goals: Discuss goals for this year.

**Attendance:** Parents from 32 schools attended the meeting. Distribution of minutes through the CPC Google group is going to parents representing 82 schools.

**Next meetings:** For the 2015/16 academic year meetings will be held the last Tuesday of each month. Dates are: September 29<sup>th</sup>, October 27<sup>th</sup>, November 24<sup>th</sup>, December 15<sup>th</sup> (third Tuesday rather than 4<sup>th</sup>), January 26<sup>th</sup>, February 23<sup>rd</sup>, March 29<sup>th</sup>, April 26<sup>th</sup>, May 31<sup>st</sup> and June 21<sup>st</sup> (fourth Tuesday). It was agreed that the meetings for the coming year would be held at the Bolling Building.

The Superintendent is required to meet with the CPC quarterly new Parent Engagement Policy the BPS' School Committee adopted in July. It was proposed, voted and approved that the co-chairs request that the Superintendent participate in the following meetings. September 1<sup>st</sup>, November 24<sup>th</sup>, February 23<sup>rd</sup>, June 21<sup>st</sup>.

Several core definitions of the CPC were discussed, including:

#### Who are we?

The CPC is the legally sanctioned organization within the City of Boston that represents parents.

#### What do we have in common?

Every parent participating has shared the experience of advocating for their school communities. Every parent shares the impacts of budget cuts.

#### How can we take action?

We are a really big group. How do we organize ourselves? What is our overall vision? Where is our access to power? Last year's sub-committees included: Budget, Equity, School Culture & Climate, School Quality, Facilities

# What are our goals for this year?

- Ensure that every school has a functioning School Parent Council (SPC). Identify schools where principals are no encouraging or facilitating engagement.
- Engage High school Redesign process, particularly around the discussion of SPED pathways
- Make better use of social media
- Improve transportation equity: highlight impacts of poor busing performance, especially for special needs
- Be a Think Tank: become the place where new ideas emerge from the parent community
- Share Best Practices.
- Host forums valuable to parents

# Committee Updates:

**ELT** report by Kristin Johnson. Locations for ELT was driven by schools with highest needs: 16 schools in total. CPC voted to support focus on schools with highest needs.

Healthy Food for Boston Public Schools Action Network from Anne Sousa (read to the group). This group is working with BPS Food and Nutrition Services with the goal of establishing the definition of "healthy food" and to eliminate certain high sugar menu items such as juice, sugar cereals, chocolate milk and jelly (ask for soy/peanut butter or cream cheese instead). They are asking that a 3rd party provide technical assistance to the district for long-term planning, including an architectural assessment and feasibility study for a central kitchen. As an immediate objective, they want to review the following:

- All (current and previous) menu options at both satellite and cafeteria schools, including ingredients and nutritional information
- Vendor offerings
- Pricing lists/cost structure
- Contracts

**Boston Education Justice Alliance (BEJA)**. BEJA is focused on fighting the Charter initiative to raise the existing cap on charter seats. If there are more charter school seats, district schools will be financially impacted. If you want to participate Mary Lewis Pierce is contact. There will be a hearing on the charter cap on October 13<sup>th</sup>.

**Mass Education Justice Initiative (MEJI)** is looking for support for testing moratorium. They would come in September.

**Facilities.** Margaret briefly described the BPS Facilities Master Plan project. She is working for the Mayor's office coordinating the project. It will be a year and a half long public process. She anticipates there will be a number of opportunities for direct CPC engagement.

Health & Wellness. Volunteers were solicited to participate in a health and wellness focus group.

YWCA Race Dialogues. Angie: Presented a proposal to approach YWCA's race dialogue team to have them explore a session with the CPC and with BPS schools - voted on and approved.

### Next steps.

- Schools need to elect parent representatives, if they haven't already. Meetings are open to all.
- Push functioning SPCs.
- Strike balance between Think Tank and acting.
